1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON
2 AMENDING THE FISCAL YEAR 2012/2013 CAPITAL IMPROVEMENT
3 BUDGET TO APPROPRIATE THE FOLLOWING AMOUNT FROM
4 HIGHWAY BRIDGE PROGRAM (HBP) FUNDS FOR THE SEISMIC
5 RETROFIT PROJECT: \$39,839 FOR BRIDGE NO. 54C-0078 (5065-015),
6 \$39,839 FOR BRIDGE NO. 54C-0079 (5065-016), \$53,118 FOR BRIDGE NO.
7 54C-0100 (5065-017), \$39,839 FOR BRIDGE NO. 54C-0375 (5065-018), \$39,839
8 FOR BRIDGE NO. 54C-0384 (5065-019) AND \$39,839 FOR BRIDGE NO.
9 54C-0599 (5065-020)

10 WHEREAS, the City Council of the City of Colton desires to improve the safety of the
11 bridges within City jurisdiction; and

12 WHEREAS, the City Council of the City of Colton has received a Highway Bridge
13 Program (HBP) Funding to complete the Preliminary Engineering Phase of Seismic Retrofit
14 for Bridges No. 54C-0078 (STPLZ 5065-015), 54C-0079 (STPLZ 5065-016), 54C-0100
15 (STPLZ 5065-017), 54C-0375 (STPLZ 5065-018), 54C-0384 (STPLZ 5065-019) AND 54C-
16 0599 (STPLZ 5065-020); and

17 WHEREAS, SAFETEA-LU 23 U.S.C. 144(d) made States eligible to use Federal
18 Highway Bridge Program ((HBP) Funds; and

19 WHEREAS, Through the HBP, Caltrans issues grants to owners of local bridges for
20 replacement of structurally deficient or functionally obsolete bridges.; and

21 WHEREAS, Funds expended by the City for eligible and approved costs are
22 reimbursable through the HBP funds; and

23 WHEREAS, a budget appropriation for approved activities, not listed in the 2012-2013
24 Fiscal Year budget is required and must be approved by resolution of the City Council.

25 NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE
