A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON APPROVING EXPENDITURE ALLOCATIONS FOR THE STATE DEPARTMENT OF EDUCATION CONTRACT CCTR-3330 FOR THE PROVISION OF SCHOOL AGE CHILDCARE SERVICES IN THE EARLY CHILDHOOD EDUCATION DIVISION OF THE COMMUNITY SERVICES DEPARTMENT FOR FISCAL YEAR 2013-14

WHEREAS, the City Council has approved the State of California Department of Education School Age Program Contract CCTR-3330 for Fiscal Year 2013-14, and;

WHEREAS, this contract provides \$177,322 of funding to enable the City of Colton to provide school age childcare services to low-income Colton families, and;

WHEREAS, the budget for Fiscal Year 2013-14 has been approved by City Council, and must now be amended to include additional expenditure allocations to properly account for all grant funding.

NOW, THEREFORE, the City Council of the City of Colton does hereby resolve as follows:

Section 1: The staff report accompanying this resolution is found to be true, adopted as findings, and incorporated into this resolution.

Section 2: The budget for Fiscal Year 2013-14 is hereby amended as follows:

Increase expenditure account 206-7200-7202-1010-0000-000 by \$71,292
Increase expenditure account 206-7200-7202-1040-0000-000 by \$37,163
Increase expenditure account 206-7200-7202-1100-0000-000 by \$11,142
Increase expenditure account 206-7200-7202-1101-0000-000 by \$24,174
