

RESOLUTION NO. R-49-14

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON TO APPEND \$80,000 OF LOCAL STIMULUS PROGRAM FUNDING THAT WAS DE-OBLIGATED IN FISCAL YEAR 2010/2011.

WHEREAS, the City Council of the City of Colton (City) desires to improve the safety of the streets and traffic circulation within City jurisdiction; and

WHEREAS, the City of Colton intends to improve the Burlington Northern Santa Fe (BNSF) railroad crossing at Laurel Street by constructing the Laurel Street Grade Separation Project (PROJECT) ; and

WHEREAS, the PROJECT received funding through the San Bernardino Associated Governments (SANBAG), BNSF, Union Pacific Rail Road (UPRR) and the City thus providing an opportunity to complete PROJECT at less cost to the City; and

WHEREAS, SANBAG is the Lead Agency for Preliminary Engineering, Right of Way Final Design and Construction Phase of the PROJECT; and

WHEREAS, the City of Colton is willing to participate in funding the PROJECT; and

WHEREAS, the PROJECT cost estimate is \$55,349,000 and the City's estimated share is \$5,511,000; and

WHEREAS, the City received Measure I Local Stimulus Program Funds from SANBAG in the amount of \$732,660.37 that will be used as contribution to the project and the City need to appropriate the remaining \$4,778,339.63; and

WHEREAS, a budget appropriation for approved activities, not listed in the 2013-2014 Fiscal Year budget is required and must be approved by resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF COLTON DOES HEREBY RESOLVE AS FOLLOWS:


