**RESOLUTION NO. R-78-14**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON TO AMEND THE FISCAL YEAR 2014/2015 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET TO APPROPRIATE \$114,762.70 FOR THE CITYWIDE PAVEMENT AND TRAFFIC SIGNAL MAINTENANCE AND REPAIR.**

**WHEREAS**, the City of Colton intends to use Measure I Funds for the Citywide Pavement and Traffic Signal Maintenance and Repair; and

**WHEREAS**, On June 17, 2014, the City Council adopted Resolution R-50-14 approving the 2013/2014–2017/2018 Measure I Five Year Capital Improvement Program and Expenditure Plan and the Citywide Pavement and Traffic Signal Maintenance and Repair was included in the expenditure plan;

**WHEREAS**, a budget appropriation for approved activities, not listed in the 2014-2015 Fiscal Year budget is required and must be approved by resolution of the City Council.

**NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF COLTON DOES HEREBY RESOLVE AS FOLLOWS:**


**Section 1** The Recitals preceding in this Resolution are true and correct and are incorporated into this Resolution by reference.

**Section 2** The City Council authorizes an appropriation of \$114,762.70. As an adjustment to the Fiscal Year 2014-2015 budget as follows:

- Increase CIP expenditure account (Citywide Pavement & Traffic Signal Maintenance) 450-1511-6970-3890 in the amount of \$114,762.70
- Increase expenditure Measure I account 218-1000-1000-5993-0004-450 in the amount of \$114,762.70
