**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF COLTON AMENDING THE BUDGET FOR
FISCAL YEAR 2014-15 TO APPROPRIATE
ADDITIONAL FUNDS IN THE ELECTRIC
DEPARTMENT FOR THE AGUA MANSA PROJECT**

WHEREAS; the budget for fiscal year 2014-15 has been approved by City Council, and must now be amended to increase the appropriation in the Electric Utility Department by \$1,895,000 for construction of the West Substation, the Agua Mansa 66 kV Switchyard and the 66 kV line to connect the two facilities (the Agua Mansa Project); and,

WHEREAS, sufficient funds are available in the Electric Department unappropriated reserve fund for the Agua Mansa Project;

NOW, THEREFORE, the City Council of the City of Colton does hereby resolve the following:

Section 1. The City Council hereby amends the fiscal year 2014-15 budget appropriation as follows:

- Increase expenditure account number 520-8000-8040-3890-0107-000
- Capital Improvement, New Substations, by \$1,895,000.00.
