RESOLUTION NO. R-13-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON TO AMEND THE FISCAL YEAR 2014/2015 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET TO APPROPRIATE \$170,000 FOR THE MT. VERNON AVE. – WASHINGTON ST. TRAFFIC SIGNAL CORRIDOR IMPROVEMENT PROJECT

WHEREAS, the City Council of the City of Colton desires to improve the traffic flow and circulation within the City jurisdiction; and

WHEREAS, the City of Colton intends to improve the Mt. Vernon Ave. – Washington St. Traffic Signal Corridor (PROJECT) in the City of Colton; and

WHEREAS, the PROJECT received AB 2766 Mobile Source Reduction Review Committee (MSRC) through the San Bernardino Associated Government (SANBAG), thus providing an opportunity to complete the PROJECT at a relatively low cost to the City; and

WHEREAS, the City of Colton is willing to participate in funding the required local match (20%) for the PROJECT; and

WHEREAS, a budget appropriation for approved activities, not listed in the 2014-2015 Fiscal Year budget is required and must be approved by resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF COLTON DOES HEREBY RESOLVE AS FOLLOWS:

Section 1 The Recitals preceding in this Resolution are true and correct and are incorporated into this Resolution by reference.

Section 2 The City Council authorizes an appropriation of \$170,000 that increases the budget for Fiscal Year 2014-2015 for the following line items:

Expenditure account #249-6150-1501-3890-0000-000 - \$34,000 (Local Match)

Revenue account #214-5742-000 - \$136,000 (Grant Revenue)

Expenditure account #214-6150-1501-3890-0000-000 - \$136,000 (Grant Expense)
