**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
COLTON, CALIFORNIA, AMENDING THE BUDGET FOR
FISCAL YEAR COMMENCING JULY 1, 2014 AND
ENDING JUNE 30, 2015**

WHEREAS, the City of Colton adopted budgets for the fiscal year commencing July 1, 2014 and ending June 30, 2015; and

WHEREAS, the City conducts regular reviews of their budgets as it is fiscally prudent to do so; and

WHEREAS, based upon the review conducted April 21, 2015, the City desires to amend the budget;

NOW, THEREFORE, THE CITY COUNCIL DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the City Council approve Professional Services Agreement Amendment with Interwest Consulting Services to increase compensation in the amount of \$60,000.

SECTION 2. That the City Council amend the Fiscal Year 2014-15 Budget to increase revenue in Account No. 100-6706-002 in the amount of \$60,000 and appropriate \$60,000 to Account No. 100-6300-6302-2350 for Building Services Division Professional Services.
