3 **SECTION 2:** Section 13.08.203 of Chapter 13.08 of Title 13 of the Colton Municipal
4 Code is hereby amended to read as follows:

5 “13.08.203 Responsibility for installation, maintenance and replacement.

6 *A. The costs for installation, maintenance, and replacement of the **Property Owner***
7 *Sewer Service Lateral (**Upper Portion**) as defined in Section 13.08.105, shall be the responsibility*
8 *of the Property Owner.*

9 *B. **The costs for installation, maintenance, and replacement of the City Sewer Service***
10 ***Lateral (Lower Portion) as defined in Section 13.08.105, shall be the responsibility of the City.”***

11 **SECTION 3:** Section 13.08.204 of Chapter 13.08 of Title 13 of the Colton Municipal
12 Code is hereby amended to read as follows:

13 “13.08.204 Responsibility for removal of Obstructions in **Property Owner** Sewer Service Laterals
14 **(Upper Portion).**

15 The City is not responsible for maintaining the **Property Owner** Sewer Service Lateral
16 **(Upper Portion)** as defined in Section 13.08.105. *To help* ~~When necessary, to~~ mitigate a sanitary
17 sewer overflow *or blockage* caused by a **Property Owner** Sewer Service Lateral **(Upper Portion)**
18 *Blockage*, the Property Owner *may request help from the City and* shall pay to the City all costs
19 associated with the remediation of such Obstruction including cleanup.”

20 **SECTION 5:** Severability. If any section, subsection, subdivision, paragraph,
21 sentence, clause or phrase of this Ordinance or any part thereof is for any reason held to
22 unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance
23 or any part thereof. The City Council of the City of Colton hereby declares that it would have passed
24 each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of
25 the fact that any one or more section, subsection, subdivision, paragraph, sentence, clause or phrases
26 be declared unconstitutional.

27 **SECTION 6:** This ordinance shall take force and effect thirty (30) after its adoption.





3 published within the City of Colton in accordance with law.


