WHEREAS, this contract will provide \$187,454 of funding to enable the City of Colton to provide school age childcare services to low income families; and


NOW, THEREFORE, the City Council of the City of Colton does hereby resolve as follows:

Section 2: City approves the State of California Contract CCTR-5196, for the provision of school age services in the Early Childhood Education Division of the Community Services Department.


Section 3: The City Manager, as Executed Director of the program, is hereby authorized to sign the applicable documents on behalf of the City to execute this agreement.
