**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON TO AMEND THE BUDGET FOR FISCAL YEAR 2014/2015 CAPITAL OUTLAY AUTOMOBILE ACCOUNT FOR THE PURCHASE OF A VACTOR 2115 PLUS JET RODDER VEHICLE**

**WHEREAS**, the Public Works Department desires to purchase one Vactor 2115 Plus Jet Rodder for the City's Collection System Division; and

**WHEREAS**, the City intends to improve the productivity and efficiency of the staff on providing collection system cleaning and maintenance of the City's wastewater infrastructure as well as the City of Grand Terrace and new developments; and

**WHEREAS**, a budget appropriation for approved Capital Outlay, not listed in the 2014/2015 Fiscal Year budget is required and must be approved by resolution of the City Council.

**NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF COLTON DOES HEREBY RESOLVE AS FOLLOWS:**

**Section 1** The Recitals preceding in this Resolution are true and correct and are incorporated into this Resolution by reference.

**Section 2** The City Council authorizes an appropriation of \$431,930. As an adjustment to the Fiscal Year 2014/2015 budget as follows:

- Increase Capital Outlay Automobile expenditure account 522-8200-8200-4910 in the amount of \$431,930.
