**WHEREAS**, the City Council subsequently adopted minor amendments to the MOP, pursuant to duly adopted resolutions, such as R-98-96 and R-29-95;

**WHEREAS**, the City Council last updated and re-adopted the MOP in its entirety on November 20, 2007, pursuant to Resolution No. R-150-07;

**WHEREAS**, the City Council has determined that the MOP should be updated and re-adopted in its entirety;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COLTON  
DOES HEREBY RESOLVE AS FOLLOWS:**

SECTION 1. The MOP dated December 2, 2014 and adopted on the same date is hereby re-adopted by this Resolution.

SECTION 2. All prior resolutions and actions adopted or taken with respect to the MOP, including, but not limited to, Resolutions R-185-86, R-98-96, R-29-95 and R-150-07 are hereby rescinded.

SECTION 3. The City Clerk shall certify to the adoption of this Resolution.


SECTION 4. This Resolution shall become effective immediately upon its adoption.
