“2.12.030 City Council Members.

The salary of each member of the city council is fixed at four hundred dollars (\$400) per month. In addition, each member of the City council shall receive an auto allowance of two hundred and twenty dollars (\$220) per month.”

Section 2. Mayor. Section 2.12.050 of the Colton Municipal Code is hereby deleted in its entirety and restated to read as follows:

“2.12.050 Mayor.

The salary of the mayor of the city is fixed at four hundred dollars (\$400) per month. In addition, the mayor shall receive an auto allowance of two hundred and twenty dollars (\$220) per month”

Section 3. Severability. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are severable. The City Council hereby declares that it would have adopted this Ordinance irrespective of the invalidity of any particular portion thereof.

Section 4. Effective Date. This Ordinance shall become effective thirty (30) days after its adoption, in accordance with the provisions of California law, but the Mayor and City Council will voluntarily reduce their auto allowances effective March 1, 2011.

Section 5. The City Clerk shall certify to the passage of this Ordinance and shall cause the same or a summary thereof to be published in accordance with California law.
