RESOLUTION NO. R-18-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COLTON, TO AMEND THE FISCAL YEAR 2015/2016 CAPITAL IMPROVEMENT BUDGET TO SET UP AND APPROPRIATE \$1,250,000 FOR THE I-10 FREEWAY/RANCHO AVENUE EASTBOUND ON-RAMP IMPROVEMENT PROJECT

WHEREAS, the City of Colton is a municipal corporation duly organized and existing pursuant to the Constitution and laws of the State of California (“City”); and

WHEREAS, the City and Caltrans will enter into a cooperative agreement for the improvement of I-10/Rancho Avenue Eastbound on-ramp (Project); and

WHEREAS, Caltrans will provide \$1.0 million State Highway Operation and Protection Program (SHOPP) funding for the improvement; and

WHEREAS, the City needs to provide a local share in the amount of \$250,000 to initiate the design and environmental phase of the Project for the purpose of acquiring Encroachment Permit from Caltrans; and

WHEREAS, the Traffic Impact Fee is a fee that is imposed by the local government within the United States on a new or proposed development project to pay for all or a portion of the costs of providing public services to the new development; and

WHEREAS, a budget appropriation for approved activities, not listed in the 2015-2016 Fiscal Year budget is required and must be approved by resolution of the City Council.

NOW THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF COLTON DOES HEREBY RESOLVE AS FOLLOWS:

Section 1 The City Council authorizes an appropriation of \$1,250,000. As an adjustment to the Fiscal Year 2015-2016 budget as follows:

- Increase Revenue in 225-5886-000 by \$1,000,000.
